2023-2024 Arizona Athletic Alliance Football League (AAAFL) Player Agreement

This Contractual Agreement is between _______ (Player Name) and the Arizona Athletic Alliance Football League (AAAFL). The season is defined as the duration between September 2022 – August 2024. Each player is responsible for his financial and personal commitment, and player development. The contract will begin from the date of signing if signing is after September 2023. Signing this agreement, the signee agrees to only participate in the Arizona Athletic Alliance Football League for the duration mentioned above. Participation in any other competitor league will result in ejection from the league.

Conduct/Behavior:

The Arizona Athletic Alliance Football League (AAAFL) maintains a high standard of conduct from all its athletes taking part each season. We believe each player represents not only themselves and their family, but also their team. Unbecoming conduct such as (but not exclusive to) fighting, drugs, alcohol, firearms, or blatant disrespect on and off the field on game day will not be tolerated in or around a 2-mile radius of any AAAFL hosted event. All conduct rules outlined by our game site host must also be adhered to. Players assessed with this offense will be levied a fine minimum of \$50 or higher based on the severity of the offense. The degree of severity and detriment of the offence will be decided by the League Commissioner and/or League Executive. All monetary fines must be paid first before suspension begins. Players are not eligible to participate on game day or be on the sideline until fines are paid in full. During this time, a player is considered not in good standing. They attend the games as a paying fan and will be held to the fan code of conduct.

Dress Code: All players are required to follow all dress code requirements for both home and away games.

- No knees can be fully exposed, if pants are above the knees, tights must be worn in the same color of the pants.
- All backplate must be fully covered.
- Numbers must be fully visible during play.
- Uniforms violations are subject to immediate ejections from the current game. Players must correct uniform violations and be cleared by a league official or game official before re-entering the game.

Ejections/Suspension:

Ejections - Any player ejected from a game will be escorted by a League/Security representative. The player must leave at once and respectfully. Once a player is no longer on the game site premises the player must also maintain a 5-mile radius from the game site premises.

Suspension: may be levied for assorted reasons as a form of discipline for unbecoming conduct/behavior.

Player fees / Registration Requirements

Responsibility:

The AAAFL is an adult minor football team that tries to promote its players to the college and professional level. It is the intent of the AAAFL to make sure no player is compensated for his play and any abuse any "loopholes" that may exist for player compensation. Any violation of NCAA compensation/gift guidelines may result in automatic suspension from participation. Players may dispute any suspension, ejection, fine or penalty. All disputes must be submitted within 48 hours after the game in which the infraction occurred.

Registration Elements Required:

- 1. Player Contract: must be received prior to the first scrimmage/game.
- Player Dues: must be paid in full based on the installment schedule due dates or prior.
 Player Registration Deadline: January 15, 2024
 Player Fee Due Deadline: January 27. 2024
 No refunds will be granted.

Changing Teams:

If a player chooses or mutually agrees to sever ties with their team. The Player is responsible for ensuring all financial obligations have been met or property returned before they are able to join another team within the AAAFL. A release must be received from the departed team. **\$150 TRANSER FEE, TRANFERS MJUST BE COMPLETED BY THE TRADE DEADLINE**

AAAFL Game Day -

Coaches have full discretion of playing time/player rotation. Players are obligated to arrive at the playing field at the time provided by the AAAFL Team. Tardiness is not acceptable. Once players enter the locker room to participate in game day activities, they are to always remain with the team unless released by the Head or Assistance Head Coach. ALL Players must check in at least one hour prior to game time unless an exception has been granted. Communication is critical and on the responsibility of the player.

Home Games

Players are required to arrange for their own transportation to any AAAFL events within Maricopa County. Lodging will not be provided for games in Arizona or "turn around" trips out of state.

Away Games

A minimum of half of AAAFL games *may* require travel out of Maricopa County or the state of Arizona. Players are required to always maintain the highest level of conduct. Players are required to travel and lodge together as a team. Accommodation and transportation will be arranged by the players' team. Exceptions can only be approved by Team ownership. Exceptions must be made a week in advance of travel. In the event of exception is granted, the player will be permitted to travel to an event separate from the team. The Player will be responsible for arranging their own lodging and transportation and provide proof of accommodation/transportation a week in advance of the event. The player will travel on their own accord and risk. Players must check in via phone call or in person upon arrival and check out when departing from the scheduled event. The player is still required to arrive at an AAAFL event at the mandated time or meet any other mandated responsibilities.
